## FOREWORD BY COURSE DIRECTOR

Welcome to the 3rd Global Webinar Conference: Updates in Imaging and Management of Liver & Colonic Tumours.

This webinar aims to present new imaging pathways and current international recommendations, and incorporate the most recent world-wide research and state-of-art diagnostic techniques. New MRI protocols and techniques will be also presented, together with advances in interventional procedures and treatment.

Lectures will cover a wide range of liver and large bowel cancers. It will include practical advice on initial diagnosis and staging process, and discuss the most relevant features determining the choice of treatment offered to each individual patient. Various treatment options will be presented to make participants aware of new developments and progress in the field of interventional radiology in order to guide their clinician discussions with patients and referrals to relevant clinical specialists.

This topic would be of interest to many General Practitioners, Gastroenterologists, Surgeons, Radiologists, Physicians and all healthcare professionals who deal with patients presenting with symptoms and diseases related to the abdominal organs.

The gastrointestinal tract is one of the most difficult systems in the human body to image, due to its length, complex structure and function, and inaccessibility for clinical examination. There are various radiological investigations available to choose from, to investigate patients with abdominal complaints, but which one is the best one and should be offered as the first choice to our patients?

This webinar will present different imaging modalities and investigations used in abdominal radiology, discussing in detail which imaging modality to use and when, and how to optimise the imaging pathway to achieve the best results.

Professor Mark Callaway, who will be speaking alongside, is a Consultant Abdominal Interventional Radiologist in the United Kingdom with a special interest in diagnostic and interventional abdominal radiology of the liver and pancreas. He has developed many techniques and was awarded the Kemp Harper prize for the best paper on abdominal imaging by Royal College of Radiologists and the Barclay prize by the British Journal of Radiology for his contributions in the area.

Together, we aim to give participants an inside and deep knowledge of new Ultrasound and MRI techniques, explaining which are the most specific and sensitive in GI diagnosis, including liver elastography, contrast ultrasound, new MRI sequences and hepatic specific MRI contrast.

This webinar will concentrate on the liver and large bowel pathology, as one of the most common sites of abdominal complaints and disease, with a significant and continuous increase in number of hepatic and colonic malignancies.

### **Professor Dr. Mark Callaway**

Professor Mark has been a Consultant Abdominal Radiologist at the University Hospital Bristol since 1998. He completed his radiological training in Manchester and Bristol before taking up a Lecturers post at the University of Bristol. He is primarily interested in both diagnostic and interventional abdominal radiology of the liver and pancreas and has developed many techniques. He was awarded the Royal College of Radiologists Kemp Harper prize for the best paper on abdominal imaging in 2005 and the British Journal of Radiology Barclay prize in 2011 for outstanding contribution to the Journal.

He has published several book chapters and over 70 peer reviewed papers on Abdominal Imaging. He was a member of the Committee that produced National guidelines for the management of acute pancreatitis in 2015, and was the only radiologist member of the NICE working party for the management of Pancreatic Cancer in 2018. He has recently completed two chapters on imaging and intervention of HCC for the forthcoming guidelines in the British Society of Gastroenterology.

He was appointed as The Medical Director of the Professional Standards and Warden of the Royal College of Radiologists in 2018, and has since then overseen several large national projects and guideline production. He was awarded a visiting Professor role at the University of the West of England in December 2015.

### **Dr. Joanna Kasznia-Brown**

Dr Joanna is Senior Consultant Radiologist and Honorary Lecturer at the University of Bristol, UK, with subspecialty in the cross sectional and paediatric imaging. She is regarded as an expert in oncological imaging, and is involved in a wide range of radiological examinations in the screening and diagnostic programs, as well as functional cancer imaging.

Joanna is currently President of the World Federation of Paediatric Imaging and Chair of Outreach Committee of the European Society of Paediatric Radiology. She is an Executive Member of the British Society of Paediatric Radiology and chairs the BSPR MRI Committee. Joanna has numerous publications and has been invited as guest and keynote speaker to many international and national conferences, and various educational courses in UK and abroad.

Abdominal, oncology and pediatric imaging remain favourite topics of her lectures and research, covering a wide range of emerging diagnostic techniques. She delivers many presentations per year, leading and organising the international courses and programmes worldwide, in cooperation with medical universities and professional societies to improve post-graduate training in diagnostic imaging across all clinical specialties. Passionate about global radiology, Joanna is a member of the International Committee, the Royal College of Radiologists, London, UK. She has been actively involved in many international projects in Africa, Asia and Europe, as Radiology Expert and Senior Consultant for the UN, WHO and IAEA.





### **Professor Dr. John George**

Prof. Dr. John George is presently the Consultant MSK Radiologist at the National Sports Institute of Malaysia and has scanned more than 6000 national athletes since 1998. He is also the Consultant MSK Radiologist at the Orthopaedic Diagnostic and Regenerative Centre at Beverly Wilshire Medical Centre where his focus is giving regenerative injections of the joint such as steroid, PRP, dextrose prolotherapy, and some limited experience with MSC.

He was formerly the Chief Musculoskeletal Radiologist at the Department of Biomedical Imaging, Faculty of Medicine, University of Malaya, Malaysia. He has 22 years of Experience in Musculoskeletal Radiology and is an expert in Musculoskeletal MRI & Ultrasound.

He is an international Course Director and Demonstrator for Musculoskeletal MRI and Ultrasound and has trained over 1000 doctors to date. Google 'Global MRI Course' for details on past and upcoming courses. He is also a Master teacher at various Radiology Musculoskeletal and Sports Medicine meetings around the world and many find his style of teaching easy to understand and can appreciate even complex topics in MSK MRI and Ultrasound. He has given more than 220 international and local presentations and has a H index of 11 for ISI publications, which is a very high score for a Malaysian Academic Medical Professor.
